Recently, NARFE President Bill Shackelford stated, "The administration's 'act first, think later' mentality in reducing the size of the federal workforce will lead to disruption of critical government operations as they chart an aggressive path towards firing hundreds of thousands of dedicated public servants."

Most of the news this month is about the turmoil going on in the government, but I'm not going to repeat it. However, I have to mention that now is a good time to donate to NARFE-PAC. That money, not dues, pays for our lobbyists to keep the legislators aware of our need to protect our benefits. Don't ignore that NARFE-PAC request when it comes.

And, when your renewal notice shows up, don't delay and end up being dropped. More than any other time, NARFE needs you now! Better yet, contact Carl to go on dues withholding.

There's news about the Social Security Fairness Act that eliminated the WEP and GPO for annuitants who also receive Social Security. The SSA has now started with back payments for 2024 and says they'll start paying the adjusted monthly rates in April. We should see those adjusted monthly rates next month!

IRS IDENTIFIES COMMON TAX ERRORS

IRS TaxTips 2024-14 identified common filing errors. (See it online at irs.gov/newsroom/irs-tax-tips)

- Missing or inaccurate Social Security numbers
- Misspelled names
- Incorrect filing status
- Math mistakes
- Figuring credits or deductions
- Incorrect bank account numbers
- Unsigned forms

Electronically filing a return reduces errors because the tax software does the math, flags common errors and prompts taxpayers for missing information.

LEGISLATION CORNER

Federal Community's Emerging Threats

As this is written, Congress has one week to adopt a budget to avoid a government shut-down. Either a whole budget (not very likely) or a short-term "continuing resolution" is needed. They want to identify ways to cut costs and allow lower taxes, too.

The news reports indicate everything is considered to be a target for reduction or even elimination. There's talk that Social Security, Medicare and Medicaid are reduction candidates. But *anything* may be targeted. NARFE has been actively working to protect our earned federal benefits. In addition, NARFE has devoted a whole section to the situation on its website at: narfe.org/advocacy/emerging-threats/. It's easy to access; you don't even need to log in to the website! Its first paragraph is copied here, so you can see it covers many aspects. Here's the paragraph:

The new Congress has its sights set on budget reconciliation legislation that could include cuts to earned federal benefits, per a list of possible cuts released by the House Budget Committee Chairman, while the incoming Trump Administration has previewed, through statements during the campaign and from administrationaffiliated individuals, a return of Schedule F, and potentially a plan to realize large-scale reductions in the federal workforce. This page provides a summary of emerging threats, where they are coming from, and what you can do about it.

What can we do? Start by supporting NARFE-PAC. Then go to the 'Advocacy' tab on NARFE's website for more options. (See the following article, too.)

As always, we must *always* let our senators and representatives know what we want, because:

Unless we speak, Congress will assume we agree!

BETTER CONTACT TO YOUR LEGISLATORS

NARFE members are often urged to call, write or email their legislators to advocate an action. New member Kent Bullard shared an update to that:

If you really want your thoughts to get to your elected legislator, don't just send an email because emails often get lost in the storm. It's much better to make a telephone call. When you call, you'll usually talk to a legislator's aide, who will record your call and opinion and then pass it directly to the legislator.

Kent also suggests using <u>5calls.org</u> as a starting point. It's available to use on a computer or can be downloaded and installed as a free app on iPhones or Android phones. It's essentially a civic engagement tool designed to make it easier for citizens to contact their elected officials. It lists a number of topics but the list isn't limited to only those of interest to current federal employees or annuitants.

What happened to the coverage for Federal Long Term Care Insurance Program (FLTCIP)?

Federal Long Term Care Insurance is not being offered to Federal Employees and Annuitants who want to enroll in this program. Premiums have skyrocketed due to the cost of care which has risen substantially, higher than the rate of inflation.

OPM is currently extending the current suspension for coverage for FLTCIP to be effective December 19, 2024, the date the suspension had expired. The suspension will remain in effect 24 months, unless OPM issues a subsequent notice to end or further continue the extension period. Individuals not currently enrolled may not apply for coverage, and current enrollees may not apply to increase their coverage during the suspension period.

OPM has determined that extending the suspension of applications for coverage is in the best interest of the program due to the ongoing volatility in long term care costs and a diminished insurance market, which are undermining thomas braniff the ability to establish benefit offerings with premium rates that reasonably and equitably reflect the cost of the benefits provided, as required under 5 U.S.C. 9003 (b) (2).

FLTCIP provides long term care insurance to help pay for costs of care when enrollees need help with activities they perform every day, or you have a severe cognitive impairment, such as Alzheimer's. It provides help to the family who may need to provide the care. It may also prevent the person needing care from having to exhaust their assets.

When the program is not suspended, most <u>current</u> <u>employees</u> must be eligible for the FEHB Program in order to apply for coverage under the FLTCIP. Note that it does not matter if they are actually enrolled in FEHB; *eligibility* is the key. <u>Annuitants</u>, on the other hand, do not have to be eligible or enrolled in the FEHB Program. Certain medical conditions, or combinations of conditions, will prevent some people from being approved for coverage. You must apply in order to find out if you are eligible to enroll.

WHO CAN INHERIT FEDERAL BENEFITS?

The online FedWeek newsletter had an article to discuss that topic in February. The article included this summary paragraph:

"Understanding which federal benefits can transfer to your spouse, children or parents is essential for effective estate planning. While TSP can be inherited by anyone you choose, FERS pensions and FEHB have strict rules that mainly benefit spouses. Dental, vision, and the FERS Supplement generally do not transfer to heirs. By making informed decisions today, you can ensure your loved ones are financially secure after you're gone."

HELP AVOID MEDICARE FRAUD

After you received your new Medicare number, you may have thought it ended any chance of fraud. Not so. It still happens, apparently frequently enough that Medicare recently issued an advisory. It offered 3 tips to protect yourself from Medicare fraud and scams:

- 1. If you get a call, text or email asking for your Medicare Number, don't respond. Don't give your Medicare card or Medicare Number to anyone except your doctor or people you know should have it.
- 2. Check your Medicare Summary Notices (MSNs) or claims statements carefully. If you see a charge for a service you didn't get or a product you didn't order, it may be fraud. If you suspect fraud, report it at 800-MEDICARE (800-633-4227).
- 3. Guard your Medicare card like it's a credit card because, in a way, it is.

One of our members, in reviewing her MSN, found a heart surgery that she did not have. It appeared to be a billing error, as her doctor had several patients with similar names. When she called Medicare to report the apparent error and provide her identifying information, they said it would be treated as a potential fraud and thanked her for calling.

Should you call if you think something isn't right? Yes indeed! They will respond.
